By signing below, I/we acknowledge that we have read and understand the following information and will also release the Sullivan Rotary Club from any liability that may arise as a result of the participation in the Sullivan Corn Festival:

**No vender may sell any of the following items, as the Carnival has exclusive rights to vend ( including similar items with different names ): Cotton Candy, Carmel-Candy Apples, Carmel Corn, Popcorn, Snow Cones, Lemon Shakes, Corn Dogs, Italian Sausage, Elephant Ears, Soft Serve Ice Cream, Curly Fires, Silly String, or Colored Hairspray.**

In addition, all tents and stands must meet fire inspection and State Fire Codes. Any vendor that does not meet the above criteria or sells items that are not allowed can be asked to leave the festival and no refund of registration fees or any other expense will be allowed.

Finally, electricity and water are provided for vendors; however, each vendor is responsible for hoses and electrical cords for their own stand. The Sullivan Rotary Club is not responsible for any of these items.

Sullivan Rotary Club (the "Club") sponsors and coordinates of the Sullivan County Corn Festival (the "Festival") and the Sullivan County Corn Festival Parade (the "Parade"). The Club does not discriminate on the basis of gender, race, age, creed, handicap, color, or national origin.
